The selection committee is submitting a proposal to conduct the first round of counseling for allied health care certificate courses for the academic year 2025-26 in August 2025. At Government Medical College, Thiruvallur, only six out of 70 sanctioned seats were filled, leaving 64 seats vacant.

To provide opportunities for deserving candidates, especially those from underprivileged backgrounds, to pursue skill-oriented certificate courses, the Principal Secretary of Health, following the referenced directive, has decided to hold District Level Admissions and walk-in admissions for the 2025-26 academic year.

This admission process will be merit-based and will strictly follow the Government of Tamil Nadu's reservation policies, including a 5% quota for differently-abled individuals, as detailed in the attached guidelines. The admission process will proceed accordingly.
